JOHN COLLEGE OF EDUCATION, 22, DWARKADISH COLONY, THATIPUR, GWALIOR-474011, MADHYA PRADESH for conducting D.ED(CO.ED) course of ELE of 2 year duration with an annual intake of 50(ELE) from the academic session 2008-2009 under clause 7(11) of NCTE(Recognition Norms & Procedure) Regulation 2007 subject to fulfillment of the following conditions:
 - i. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund account into a joint account to be operated along with an officer of the Western Regional Committee.

ii. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

iii. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.

iv. The institution shall ensure that the required number of academic staff for conducting the course is always in position.

- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, applicable.
- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
